1. Purpose

This Policy supports the *Student Admissions Policy*. It specifies the requirements for recognition of prior learning at Australian School of Accounting (**ASA**), in accordance with the Australian Qualifications Framework (AQF) and the AQF Qualifications Pathways Policy.

This policy ensures that decisions about credit will not disadvantage applicants, nor diminish the integrity of ASA's accredited higher education courses. Student admission into ASA is based on academic merit and/or demonstrated ability and meeting course entry requirements; all decisions relating to student admission are consistent; and standard eligibility requirements are publicly available.

2. Scope

This policy applies to all ASA applicants, students, and staff who support these processes.

3. Principles

This Policy is informed by the principles of the AQF and supports the commitment of ASA to:

- 1. transparency;
- 2. ensuring that the process of assessing applications for recognition of prior learning is fair and equitable; and



3. maintaining the integrity of ASA's courses and units.

4. Definitions

Term	Definition		
Advanced Standing	Advanced standing describes a form of credit for previous learning. It involves the application of credit towards a student's course of study, usually in respect of entering a course at an advanced stage.		
applicant	A person who has applied to study at ASA.		
Articulation Agreements	Articulation Agreements or Arrangements create a defined pathway that enables a student to progress from a completed course of study to another course of study with admission and/or credit. At ASA these are between different providers.		
census	The census date is the last date for a student to withdraw from a unit without incurring the financial liability or academic penalty for the unit.		
commence	To start a course. The commencement date is the first day of the study period that a student is enrolled in a unit. This does not include units that have been granted Advanced Standing or exemption.		
Confirmation of Enrolment (CoE)	A Confirmation of Enrolment (CoE) is a document issued by ASA to verify the applicant's enrolment in a specified course. This document is required for students that require a Student Visa.		
Credit Transfer	A process that provides students with agreed and consistent credit outcomes for completed components of a course of study based on identified equivalence in content and learning outcomes between matched courses of study.		
higher education provider	 Defined in the TEQSA Act as: a constitutional corporation that offers or confers a regulated higher education award; a corporation that: offers or confers a regulated higher education award is established by or under a law of the Commonwealth or a Territory a person who offers or confers a regulated higher education award for the completion of a course of study provided wholly or partly in a Territory. 		
key dates	Key dates are dates that state when an important event or deadline starts or ends. These dates can impact financial, academic or administrative actions and students should ensure they are aware of all key dates.		
professional body	Professional bodies (or associations) are organisations that act as a peak body or umbrella for professionals working in the same or similar fields.		
Recognition of Prior Learning	Recognition of Prior Learning (RPL) is an assessment of an individual's prior learning to determine whether credit will be granted. RPL includes formal, informal, and non-formal learning.		
Registered Training Organisations (RTOs)	Registered training organisations (RTOs) deliver nationally recognised training in the VET sector. To deliver this training, they need to be approved by ASQA. RTOs are the only organisations in the Australian VET system authorised to: • deliver and assess nationally recognised training • issue nationally recognised qualifications and statements of attainment • apply for government funding to provide VET services.		



satisfactory course progression	 Students must meet minimum course progression standards by: Not failing a particular unit of study more than once. Passing 50% or more of the units of study attempted in a study period. Ensuring they enrol after an approved study break (Leave of Absence); or Are not able to complete their course within five (5) years of commencement.
unit	A unit is a component of study which forms part of a course. At ASA most units are worth 10 credit points and most courses require completion of 24 units.
Vocational Education and Training (VET) providers	VET providers are government organisations or businesses that provide nationally accredited training. The courses offered align with the AQF and they must be registered with ASQA, see RTOs.

5. Policy Statement

Any student with prior learning may submit appropriate evidence and apply for Recognition of Prior Learning. ASA may award credit towards achievement of a qualification or award for various forms of prior learning by comparing a student's current level of skills and knowledge against Unit Learning Outcomes.

5.1 Types of Recognised Prior Learning

Applying for Recognition of Prior Learning involves assessment of a range of prior learning modes and undertakings, which includes, and is not limited to:

- 1. units which form part of an accredited course of study provided by a recognised higher education provider;
- 2. accredited vocational education and training providers (VET);
- 3. non-award courses offered by ASA or a recognised higher education institution;
- 4. accredited courses of study provided by a Registered Training Organisation (RTO); and
- 5. recommendations contained in the AQF.

ASA may, at its discretion, recognise the validity of other forms of training or education, providing they are deemed equivalent to, or meet, the AQF standards.

Single units from overseas higher education institutions will not be granted credits as they are not recognised by the AQF standards.

5.2 Rules Governing Recognition of Prior Learning

Entry to courses offered by ASA is based on specific published entry criteria. Decisions regarding student selection will be in accordance with the *Student Admissions Policy* and *Student Admissions Procedure*. An offer of credit for advanced standing based on prior learning does not guarantee admission into a specific course.

All applications for advanced standing will be assessed on a course-by-course basis. The assessment of the amount of advanced standing to be granted in particular courses shall be determined by the Academic Dean, or delegate. Once appropriate documentation is submitted, an application for Recognition of Prior Learning will be reviewed within ten working (10) days.

Specific rules are:



5.2.1 Specified/Unspecified Credit

Specified credit is granted for specific units. Unspecified credit may be used to replace electives in a course, provided it is at the same or similar study level.

5.2.2 Level units granted for Advanced Standing

Credit, whether specified or unspecified, will not be granted for any core units at third year (300) level for any course offered by ASA.

5.2.3 Automatic Exemptions

Automatic Exemptions may be awarded to students who have completed previous studies with an education provider that has a current, approved articulation agreement or Memorandum of Understanding. Automatic Exemption arrangements are approved by the Academic Dean, or delegate.

5.2.4 Maximum Exemptions

The total credit granted for prior learning external to ASA will not exceed 50% of the total credit points required for the award for which the credit is sought.

5.2.5 Work Experience

Credit may be based on a mixture of formal study and work experience. However, no more than 25% credit will be granted for work experience. Work experience should be within the last five (5) years, or reviewed on a case-by-case basis in extenuating circumstances.

5.3 Advanced Standing Conditions

Advanced standing may be granted for:

- Formal study completed no more than five (5) years prior to application, on the
 condition that there is sufficient evidence of continued relevance of content, learning
 outcomes, and where the student is judged by the Academic Dean to have the same
 probability of successful completion of the ASA course as a student completing the
 entire course.
- 2. Non-award courses, as well as for courses provided by a professional associations or similar bodies, where appropriate learning outcomes have been rigorously assessed and documentation is provided.
- 3. Criteria set by professional bodies may also apply.

Advanced standing will not normally be granted for formal study completed more than five (5) years prior to enrolment unless there is evidence of continued relevance of this study for the course towards which advanced standing is sought.

5.3.1 Challenge Examination

In cases where the granting of recognition of prior learning is unclear the Academic Dean may elect to instruct the candidate to complete a challenge examination to fully determine recognition of prior learning. This could occur with recognition of prior work experience cases. A challenge examination will only apply to units of study that have no pre-requisites.

5.4 Assessment Criteria

Assessment criteria applied to applications for Recognition of Prior Learning include:

assessment methods



- duration of course
- admission requirements
- learning outcomes and objectives
- the scope, depth and content of the course/unit material
- the general educational practices and standards of the provider.

5.5 Credit Transfer within Australian School of Accounting

Transfer of Credit may be granted when a student has completed units whilst undertaking a course of study with ASA and wishes to transfer to another course before completing the prior course. An application for credit transfer can be made upon enrolment. Credit will be granted for those units already undertaken which form part of the course into which the student is transferring. The grade awarded for the unit completed in the previous course will transfer to the new course.

5.6 Articulation Agreements

ASA may enter into agreements with specific institutions to provide graduates of specific courses of study offered by another institution credit for particular units which form part of an ASA course. The following processes and conditions apply:

- Prior to entering into Articulation Agreements, ASA will map the competency units or specified learning outcomes provided by the institution against the learning outcomes provided by the unit within the relevant ASA course.
- The Academic Dean will review and approve all Articulation Agreements.
- Articulation Agreements will only cover credit for specific, predetermined units.

Institutions applying for Articulation Agreements with ASA should be able to establish and verify that they have benchmarked themselves against institutes that have met industry standards. ASA reserves the right to revoke Articulation Agreements in cases where there is a clear trend that the advanced standing granted under articulation agreements have resulted in poor student performance.

5.7 Cross-Institutional Study

Students enrolled in an ASA course who wish to study an equivalent unit at another recognised provider should consult the Course Coordinator about the process and eligibility criteria. The above Advanced Standing rules apply.

5.8 Grievances

An applicant or student may complain against a decision made under this Policy and Procedure. Complaints must be made as prescribed in the process outlined in the *Student Grievance Policy* and associated *Procedure*.

5.9 Progression

Students who have received recognition of prior learning will be monitored during their course enrolment to ensure that they are not disadvantaged due to the application of credit and that they make satisfactory course progress.

6. Relevant HESFs

This Policy and the associated Procedure comply with the Higher Education Standards Framework (Threshold Standards) 2021. The following are relevant excerpts and specify that:



Standard 1.2 Recognition of Prior Learning

- Assessment of prior learning is undertaken, consistent with the credit and recognition
 of prior learning policy in the Australian Qualifications Framework, for the purpose of
 granting credit for units of study within a course of study or toward the completion of
 a qualification. Such assessment is conducted according to institutional policies, the
 result is recorded and students receive timely written advice of the outcome.
- 2. Credit through recognition of prior learning is granted if:
 - a. students granted such credit are not disadvantaged in achieving the expected learning outcomes for the course of study or qualification, and
 - b. the integrity of the course of study and the qualification are maintained.

Standard 1.5 Qualifications and Certification [...]

- 7. Records of results state correctly, in addition to the requirements for all certification documentation: [...]
 - b. credit granted through recognition of prior learning

Standard 7.2 Information for Prospective and Current Students [...]

- 2. Information for students is available prior to acceptance of an offer, written in plain English where practicable, accompanied by an explanation of any technical or specialised terms, and includes: [...]
 - information to assist in decisions about courses or units of study, including the course design, prerequisites, assumed knowledge, when and where courses/units are offered, application dates, arrangements for recognition of prior learning, standing credit transfer arrangements, pathways to employment and eligibility for registration to practise where applicable [...]
 - d. information to give access to current academic governance policies and requirements including admission, recognition of prior learning, transition, progression, assessment, grading, completion, qualifications, appeals, academic integrity, equity and diversity, intellectual property and withdrawal from or cancellation of enrolment [...]

Standard 7.3 Information Management [...]

- 2. The list of all higher education courses of study within the repository of information includes: [...]
 - g. details of the credit and recognition of prior learning policy that applies to each course of study and direction on how to obtain information on any articulation or credit arrangements that may apply to the course.

7. Version Control

This Policy has been reviewed and approved by the Australian School of Accounting Academic Board as at February 2024 and is reviewed every three years.
